The meeting was called to order at 12:34 pm.

#### 2. Approval of Agenda

#### 3. Adoption of Minutes

Minutes from the October 2, 2020 Solid Waste Advisory Committee meeting. Amend Item 8, Other Business, by adding text: is currently "requesting offers from qualified candidates to provide support for the development of Key Performance indicators and Targets for Zero Waste Victoria". The response date is October 6, 2020 and he wondered about coordination with CRD thinking after City of Victoria.

#### 4. Chair's Remarks

Welcome to Margaret McCullough who was appointed by the Board on October 14. Margaret joins us on the committee as a representative of an *Environmental Organization* (Surfrider Foundation).

Welcome to James Collins who was appointed by the Board on October 14. James joins us on the committee as a representative of *Private Sector Industry Collection Service Providers* (Tymac Launch Services Ltd.)

Stew Young has resigned as Vice-Chair but will remain on the committee. At the December meeting, we will elect a new Vice-Chair. There will be a call for nominations at the December meeting and then a vote.

I want to thank those committee members who attended the Coast Waste Management Association in October and a thank you to M. Kurschner who presented at the conference.

#### 5. SWAC Self-Assessment/Effectiveness Review

R. Smith provided an update on process and the steps of the self-assessment (Appendix A). The committee will complete this survey in December 2020, it will go to Environmental Services Committee in February 2021 with direction coming back to SWAC in March 2021. The following comments were made:

- This survey will be anonymous and can be completed electronically or in hard copy format and submitted in an envelope.

#### 6. Update on October 14, 2020 CRD Board - Staff Report: Solid Waste Management Plan - Next Steps

N. Taylor summarised the results of the Board meeting. The Board recommendation was:

The Environmental Services Committee recommends to the Capital Regional District Board:

- 1. That the waste reduction target remain at 250 kg/capita/year by 2030 but goal 1 be changed to read "To surpass the provincial per capita waste disposal target and achieve 125 kg/capita/year";
- 2. That the Solid Waste Advisory Committee's recommended additions be added to the draft Solid Waste Management Plan; and
- 3. That staff proceed with community and local government consultation on the draft Solid Waste Management Plan, including targeted stakeholder consultation with residents in the areas of Hartland Landfill, Prospect Lake, Willis Point and Highlands.

#### R. Smith noted there was a motion arising from the Board meeting:

That staff report back on the first annual report on the Solid Waste Management Plan on measures that can be taken to achieve more aggressive waste reduction targets. R. Smith highlighted that the current strategies and actions will remain in the plan that work towards a 250kg/person target. In a years' time, a review will be done on how things are moving along and at that point the strategies and actions could be revisited.

R. Smith presented a slide on the timeline for finalizing the plan (Appendix B). M. Tromp-Hoover updated the committee on the approach for Phase Two Consultation (Appendix C). The second round of consultation will be done with Municipalities/Electoral Areas, First Nations, Neighbouring Regional Districts, General Public and Hartland Neighbours. Following consultation there will be a Phase Two Consultation report and these results will be incorporated in to the final plan. A discussion ensued and the following clarification was give on the Phase Two Consultation plan:

- SWAC will see the proposed consultation approach and the revised draft plan
- The consultation open houses will be done via *virtual townhall* tours and will be through a live stream on YouTube
- Consultation will be done using the November draft Solid Waste Management Plan (which includes feedback from SWAC and Board endorsement).
- There will be refinement to some materials from Phase One Consultation to ensure better consultation for Phase Two
- The consultation report will come back to Environmental Services Committee and the CRD Board for feedback and direction.

S. Gose brought forward the below motion and an extensive discussion ensued:

That the Solid Waste Advisory Committee recommends that the Environmental Services Committee recommend to the Capital Regional District Board that the potential additional actions required to achieve the 2/3 waste reduction by 2030, as outlined in Table 2 of the September 16, 2020 ESC staff report, be incorporated into the draft Solid Waste Management Plan.

#### MOVED S. Gose, SECONDED R. Tooke

The guestion was called on the main motion with amendments.

That the Solid Waste Advisory Committee recommends that the Environmental Services Committee direct staff to report back on options and recommendations on ways the potential actions, as outlined in Table 2 of the September 16, 2020 Environmental Services Committee staff report, can be incorporated after consultation and before the final draft Solid Waste Management Plan goes back to the Environmental Services Committee for approval.
