 - Further discussion on Food and Ag initiative Ed Andrusiak

Ed gave an update on discussions with the Southern Gulf Islands Community Resource Centre (SGICRC) and Gulf Island Food Co-op (GIFC). GIFC sent in a proposal to CESC last meeting. It was determined that the CESC will need to review funds remaining for the year 2020. Andrea Mills joined the meeting and discussed other external funding opportunities that could bring a larger scope of work and include other food security groups on the islands. It was recommended Commissioner Elliott submit a pre-screen form to UBCM for Community Works Funds and get an idea of eligibility for the project. In the meantime, Commissioner

Elliott and Melody will review the remaining 2020 budget for SGI CESC. To be further discussed at the December meeting.

8. New Business

Rural Island Economic Partnership (RIEP)

Commissioner Hoebel gave a brief background of these two services.

Shared Business Services

Rural Dividend Funds was awarded Salt Spring Island Community Economic Development Commission (CEDC) for a pilot project to provide shared business services across the Southern Gulf Islands and Salt Spring, some of which would include marketing and sales, technical and administration Support, human resources, training opportunities and supplies purchasing. The CEDC recommended that the CEDC contract with RIEP to deliver the pilot program.

Island Comeback

This is a website set up to provide gift card purchases or donations to rural island businesses and non-profits. It will eventually set up an ecommerce is more funding is secured. They are currently gearing up for Christmas.

SGI Tourism Partnership (SGITP)

Ed discussed the status of SGITPS. They have hired Chris Hall as Project Manager for the Canadian Experience funds they received and he is working on a strategy for interisland connections both water and land. They are interested in working together with CESC to coordinate with the transportation service initiative. Meetings are being planned to ensure work is not being duplicated.

• Island Coastal Economic Trust (I.C.E.T.) – Ian Elliott

There was discussion regarding I.C.E.T. and Community Futures inclusion. It was mentioned by Staff that the I.C.E.T. funding was limited and no clear decision from Government if a top up in funding was coming. Commissioner Goldman mentioned that Adam Olsen would be advocating for the Salt Spring Island and the Southern Gulf Islands once he has been sworn in. Commissioner Elliott also mentioned that by including Juan de Fuca it may set a precedent that opens the door for further discussion to include the other 2 electoral areas.
