SUBJECT Grant Update

ISSUE SUMMARY

To provide the Commission with information on the current status of grants.

BACKGROUND

Staff are working to submit several grant applications in response to grants that have come available over the past month. If successful, these grants will reduce project costs for pending projects or provide additional amenities to the community without budget requirements.

<u>Investing in Canada Infrastructure Program Green Infrastructure – Climate Change Mitigation</u> Sub-Stream CleanBC Communities Fund

This grant submission is for \$1,972,430 for the design and installation of a heat recovery system that will harvest rejected heat from the refrigeration plant and use that heat along with high temperature heat pumps to displace large gas consuming building processes. These processes include arena dehumidification, domestic hot water, and space heating in various areas of the facility. This project is approved and planned pending grant funding. The proposed start date is April 1, 2021 and the completion date is January 1, 2023.

New Horizons Grant for Seniors: Community Garden Improvements at Greenglade Community Centre

This grant submission is for \$25,000 for expansion and improvements to the community garden. There is an extensive waitlist for the existing garden and it is currently not very accessible. The grant would add at least 20 more plots to the garden and improve accessibility by providing wheelchair accessible plots and raised plots. Additionally, it would facilitate installation of a covered shelter in the garden and would allow garden members, primarily seniors, to socialize in a safe, COVID-19 friendly environment and would be used to host workshops for the community. Matching funds are not required. The proposed project start date is March 1, 2021 and the end date is November 1, 2021.

<u>Community Economic Recovery Infrastructure Program: Revitalization of Greenglade Community</u> Centre Outdoor Space

This grant submission for \$309,000 is for an accessible playground for children 2-12 years and an outdoor shelter for community use and outdoor workshops/classes. A new playground would meet Island Health licensing expectations and allow an additional outdoor and COVID-19 friendly space for the existing Out of School Care program. It could also help facilitate the growth of licensed child care programs within Greenglade. A shelter would provide a COVID-19 safe space for community members to meet as well as provide a space to host workshops for the community.

The overall project would include community consultation, removal of the current play structure, reconstruction of the play surface and installation of updated amenities (playground and shelter).

No matching funds are required. The proposed project start date is March 1, 2021 and the end date is September 30, 2021.

IMPLICATIONS

Financial Implications

The heat recovery system grant, if approved for full funding, would leave a remaining capital commitment of \$852,670 for Panorama Recreation. The grant funding for the Greenglade community garden improvements and outdoor space, if successful, would not require additional funding from the operating or capital budgets.

Service Delivery Implications

The Out of School Care program is only permitted to utilize the existing playground once per month due to licensing limitations. A new playground would facilitate daily play on the structure and surrounding area. It would also allow for potential growth of licensed child care programs to a younger age group. The proposed shelters would be used for outdoor workshops and programs.

Alignment with Board & Corporate Priorities

The heat recovery grant would align with the Board and Corporate Priority to reduce greenhouse gas emissions from buildings. The grants for the outdoor Greenglade space align with the Corporate Priority to ensure residents have access to appropriate and affordable recreation opportunities as the new outdoor spaces would be free to access for the public and would facilitate recreation and social connectedness during the current pandemic.

Alignment with Existing Plans & Strategies

The heat recovery project aligns with the CRD Climate Action Strategy as well as staff work plans. The expansion and improvements to the Greenglade community garden align with 2020 work plans to ensure sustainability of the community garden program. The Greenglade playground and outdoor space projects align with plans to replace the playground already in place through the capital budget as well as current funding support from Kiwanis.

CONCLUSION

Staff are pursuing available grant opportunities to reduce the financial impact of existing projects and provide additional facilities for the community without additional cost.

SUBJECT Maintenance Update

ISSUE SUMMARY

To provide information on the Maintenance Department.

COVID-19

As a result of COVID-19 safety requirements, staff are performing enhanced cleaning and disinfecting measures in all areas. Touch points throughout the facility are sprayed with Health Canada COVID-19 approved cleaners twice a day during operations as well as once overnight as part of the regular cleaning routine. Arena change rooms are sprayed between each group usage. Maintenance staff have also been assisting other departments as needed with their enhanced cleaning requirements.

High Voltage Upgrades

To extend its service life, the main transformer for the Panorama Recreation site will be lifted off its current pad and releveled; fuses will be changed and oil will be added. Other upgrades include the installation of additional lightning arrestors and an asphalt pad at the main disconnect. This work will require two separate power outages. The first will be a 1-2 hour outage that will not impact operations. The second will be a 12-14 hour outage. Staff are currently working with the contactor to determine an appropriate time to minimize operational impact.

Pool Slide Railing

A new polished stainless steel guard and handrail system has been installed on the pool slide staircase. This project was completed on budget.

Arena B Power Distribution

The Arena B power distribution project is complete. This project created little disruption and was completed under budget.

CONCLUSION

The above repairs and improvements are part of the capital and long term preventative maintenance plan.
