  - Fitness class and weight room attendance remains steady. More hours added. Personal training has been reintroduced
  - o Arena programs winding down. Public skates were at capacity for most of season
- Administration:
  - Golf course: scheduled to open March 25, 2021. SEAPARC will be balancing staffing levels with increased public demand and safe access. During winter closure work was done on well repair, net installation, and green mower replacement.
  - Fees and Charges: Annual review of fees and charges underway. Limited 25 admission promotional pass for adults and seniors has been introduced. All membership passes, minus golf pass, are still on hold until Provincial Health Restrictions removed. Fees for sport box underway.
  - Fitness Expansion: To be completed in coming months: bench installation, landscaping, and bear resistant trash can installation.
