6.1 Arts Advisory Council Update

6.1.1 Arts Advisory Council Chair's Report (Verbal)

Chair Heiman reported on the following:

- There would be several new members on the 2021 Arts Advisory Council, as some members have completed their maximum allowed terms.
- A subcommittee was formed to consider how more consistent information on the restricted funds that organizations report on in the financials for Operating Grants could be gathered. A line in the regular application was identified where the size and

- purpose of an organization's restricted funds could be reported. The goal is to add to the understanding of organizations' financial status and sustainability.
- A 2019 report showed over 9,000 jobs dependent on the arts. While it may be easy to talk about how the lack of live performances due to COVID-19 means missing the enjoyment of performances, it is important to remember the economic impact through loss of employment.
- Equity, Incubator and IDEA Grants will be the next adjudication and the Council will bring those recommendations to the Commission at a future meeting.

Discussion and clarification ensued on the following topics:

- First Nations groups have access to grants if they meet the basic criteria and have been funded through both Project and Equity Grants. There are impediments to support of First Nations groups that are based in non-participating jurisdictions. Arts staff are examining this issue through CRD First Nations Relations.
- The Commission suggested an orientation for new members of the Arts Advisory Council would be beneficial.

6.2 January 2021 Project Grant Recommendations

J. Lam shared the covering list of the grant recommendations, now on file at CRD Finance and Technology. He provided highlights of the report and the grant recommendations.

M. Heinz provided information on the adjudication process and feedback given to applicants.

The Commission sought further information on:

- The reasons some applicants were not successful in obtaining a grant.
- Applicants provide financial information and project budgets in their applications, the clarity of which informs the adjudication.
- Applicants get a letter noting the reasons for decisions; part of the Arts & Culture Service grant purpose is developing organizational capacity, so the feedback to applicants is relevant.
- This first intake of two in the year amounts to slightly less than 50% of the \$240,000 total funds of the Project Grant program.
- Grant recommendations balance the level of request and the available funding. Fewer applicants at this intake and a consideration of revenue generation issues due to COVID-19 restrictions resulted in a higher level of support than is typical.

6.3 Outreach Update

6.3.1 Results of Survey on Impact of COVID-19 on Funded Organizations

V. Jeevanandam provided highlights of the report and responded to questions from the Commission.

- 12% of respondents who reported increased budgets during COVID-19 situation were likely smaller organizations benefitting from emergency support from other levels of government.
- Survey results will be communicated by staff via media release with the Arts at a
 Distance report appended. Results will also be included in the regular eNewsletter to
 arts organizations, by the Chair in outreach to non-participating jurisdictions and by
 Commission members to colleagues on their respective councils.
- The resilience shown in the arts community is worth acknowledging; finding creative ways to work under the Health Authority orders is a huge challenge and learning how to do things online is not a simple thing.

6.3.2 Outreach to Non-Participating Jurisdictions (Verbal, Chair Loveday)

Chair Loveday reported on the outreach activities to non-participating jurisdictions.

- A letter was sent to councils offering a presentation by Chair Loveday and J. Lam on the benefits of joining the service, including benefits to organizations within the jurisdictions. Responses were received from some jurisdictions, while others did not respond or only received the letter as information.
- Chair Loveday and J. Lam were invited to present to Sidney and Colwood councils. Colwood council has requested a follow up presentation for further information.

Discussion included the following points

- The CRD Board adopted as a strategic priority 100% participation in the arts services.
- The Board also said the Arts Commission would lead the pursuit of 100% participation.
- Jurisdictions that already participate are subsidizing those who benefit but who are not supporting it. From the *Building our Arts Future* study, people agree that the arts service should be regional.

- After the outreach is done, if 100% is not reached, it was suggested that the Commission may recommend to the Board that participation should be mandatory as part of a regional service.
- An end date to this engagement period should be established, so there is a timeline to receive a response or note of interest, and another letter sent to the non-participating jurisdictions with a requested response time.
- At the close of the engagement period, if 100% participation was still not reached, then
 the Commission could discuss reporting back to the Board on the delegated priority
 and what the Commission's recommendation to the Board would be.

REPORT TO THE ARTS COMMISSION MEETING OF WEDNESDAY, MAY 26, 2021

SUBJECT: 2021 IDEA Grant Recommendations

ISSUE SUMMARY

The 2021 IDEA Grant recommendations are presented for Arts Commission review and approval.

BACKGROUND

The IDEA Grant program supports and encourages initiatives by non-arts mandated organizations, or those that may not otherwise be eligible for other CRD programs, to develop and use arts programming in the delivery of their mandates.

A total of 17 applications were received. Eight applicants were first time applicants to the program. Nine applicants were returning applicants all of which had received previous funding under the program. A total of \$49,815 in requests was received.

An adjudication committee assessed each of the 17 applications using a scoring matrix that reflected the desired outcomes of the program in the areas of:

- Project description and how the need for the project was determined
- Key personnel
- Fulfillment of the goals of the IDEA program
- Knowledge of the target audience
- Reasonableness of budget and projected expenses and revenues

The jurors' scores provided an aggregate assessment of each organization's proposal. Final Reports from previously funded projects were reviewed as applicable. After considering the assessment scores, the grant requests and the available funding it was clear that not all applications could be funded. The available funds for this deadline totaled \$35,000.

Three applicants with the lowest overall scores are not recommended for funding. Of two organizations with similar scores the Sooke Museum, a new applicant that proposed a completely new project is recommended for funding instead of the Harmony Project. The Harmony Project was a returning applicant and its proposal was for an extension to an established program that the jury considered to be less of a priority than new programming.

Six of the thirteen recommended grants support first time applicants. The results of the adjudication were presented to the full Arts Advisory Council for discussion, were ratified and then recommended for consideration of approval by the Arts Commission. Summary pages are provided for each application and are attached to this report.

ALTERNATIVES

Alternative 1

The Arts Advisory Council recommends to the Arts Commission:

That the \$35,000 in 2021 IDEA Grant recommendations be approved as presented.

Alternative 2

That the 2021 IDEA Grant recommendations be approved as amended.

Alternative 3

That the recommendations be referred back to the Arts Advisory Council for further information.

IMPLICATIONS

A total of \$49,815 in requests was received for proposals with cash budgets totaling \$362,915. The jury recommends total funding of \$35,000 to 13 organizations. This will fully allocate the 2021 budget for IDEA grants.

CONCLUSIONS

Thirteen applicants are recommended for IDEA Grant funding. The recommended projects fulfil the desired purpose and outcomes of the IDEA Grant program.

RECOMMENDATION

The Arts Advisory Council recommends to the Arts Commission:

That the \$35,000 in 2021 IDEA Grant recommendations be approved as presented.

Organization Mandate:

Active / Passive Performance Society has a mandate to:

- 1. Bring creative, experimental, singular and exceptional music to the Southern Gulf Islands via performances, installations, broadcasts, workshops, residencies and more;
- 2. Build an audience and community for new and exciting creative endeavours, including music, media and technology; and
- 3. Amplify and support diverse artist voices from throughout the Pacific Northwest.

Project description

Active / Passive Vol. 3 is the third annual ambient music festival located on the shared and unceded traditional territories of Penelakut, Lamalcha, Hwitslum and other Hul'qumi'num speaking peoples - what is now known as Galiano Island. This community arts festival is presented and/or filmed at the Yellowhouse Art Centre, and showcases artists from on and off-island to perform ambient and experimental music in a gorgeous natural amphitheatre in the heart of Sturdies Bay.

The festival encourages performers to collaborate with others wherever possible in order to facilitate the exchange of innovative ideas and approaches. Featuring Galiano locals as well as folks from across the Salish Sea, Active / Passive allows artists and audience members to connect and perform in a supportive, safer space surrounded by a community of peers. Due to COVID, we will again expand the festival by broadcasting the performances for free online over three days, showcasing 10-14 artists. The broadcast premiere will weave prerecorded performance footage with custom-designed effects created by visual artists.

The Need

As long-time musicians ourselves, we founded Active / Passive to fill a gap in BC's festival offerings by focusing specifically on ambient and experimental electronic music. We aim to showcase artists at the beginning of their career, those changing their genre or process and those with established careers, in order to support innovation in artists' practices and develop Galiano audiences. There is currently only one other music festival that includes performances on Galiano Island, Tour des Iles, but it is an event for all Southern Gulf Islands. No other music festival takes places solely on Galiano Island at this time.

This year Active / Passive also meets an urgent need in providing income to individual artists who have lost revenue streams from ticketed live events.

"The first thing I'm gonna do on the street is pet my dog."

"Yeah, I wanna do costume design on the street, too."

Unfortunately, due to Covid-19, many men who were released during the pandemic weren't able to do all of the things they wanted to do on the street. Some of them couldn't see their families who lived in other communities, or connect with their cultural leaders. One man, whose statutory release meant he was not eligible to attend a halfway house to help him transition into the community, has described being given a list of homeless shelters in Victoria in June of 2020.

On the Street will be a three-phase project:

Phase One: Conduct interviews with formerly incarcerated people who were released from prison during the Covid-19 pandemic. Interviewees would be given an honorarium for their participation.

Phase Two: Transcribe interviews and organize into a verbatim play script. A verbatim play is a play that uses the actual words spoken by interviewees arranged in an artistic and theatrical way.

Phase Three [NOTE: this grant will only focus on Parts One and Two] A future public performance that could take place digitally or in person, depending on Covid-19 restrictions.

The project features a series of three Creekside Concerts, which will take place in various outdoor venues along Bowker Creek. The creek begins on the campus of the University of Victoria and runs through eleven different neighbourhoods and three CRD municipalities before emptying into the Salish Sea. Each concert will be free and open to the public and will feature performances by a local poet and musicians (amplified by a bicycle-powered sound system) as well as interactive visual art activities that attendees of all ages can participate in. We intend to host a concert in each of the three municipalities: Saanich, Victoria and Oak Bay. All three concerts will be recorded and broadcast on YouTube, giving the opportunity for people who cannot attend in person to enjoy the benefits of the events.

After producing a very successful second season of Creekside Concerts in 2020 in spite the pandemic, we are excited to continue to address the major lack of awareness that most residents of the CRD have of Bowker Creek. More than 60% of the waterway is covered over and many of the segments that are above ground are fenced off and hidden from view. We have found that music, poetry and visual art are excellent tools for bringing Bowker Creek into the consciousness of those who have never noticed it, and also to create an expanded awareness of the watershed in people who do know about it.

We received a large amount of positive feedback from residents who attended the series over the past two years and the warm reception that we experienced reinforced that using the arts to pursue our mandate and to reach a new and wider audience is an effective strategy. With few other opportunities to listen to live music and poetry in person in 2020, many attendees described the events as a highlight of their summer.

We are excited that Brianna Bear from Songhees Nation will take part in series again this year, welcoming attendees at each event to Lekwungen Territory and to sharing words and songs about Lekwungen people's relationship to the land and water.

We have made contact with local artists and have a vision of a mural that pays tribute to the building's and neighbourhood's past. Past businesses included a gas station, a grocer, a shoe repair shop, a hardware store, and a barber shop. There are steps down to the cycle shop from Burnside Road, and interestingly, the building was originally street level, but Burnside Road has been raised since then, making the main entrance no longer street level.

While this is our initial vision, we will develop a very high-level guideline of basic parameters of the project to issue to a list of muralists that we've compiled with a call for expressions of interest and concepts.

The Burnside Road corridor is somewhat run down and is a major commuter route. The wall in question is a large blank wall which has very high visibility for residents and visitors to our community. Professional musicians/music educators from the Sooke Philharmonic Society started HPS in 2016 because they understood that in a town where almost 30% of the population was living below the poverty line, its children needed cultural, social, and academic support. They knew from their experiences of the Los Angeles Harmony Project on which HPS would be modeled, that learning to play an instrument would provide cultural and developmental support, build confidence and self-esteem, create a positive environment where children could thrive, and broaden children's horizons so they could enlarge their life goals. They started with one Strings class and one Drumline group. They now have three Strings classes and are being pressed for a fourth. Last fall, the Drumline Corps, originally open to middle school students and older, experimentally recruited nine elementary school children and the Drumline teachers now want to create a Junior Drumline.

During the covid-19 lockdown in 2020, HPS teachers moved their music lessons outside, online, and into small, masked, socially distanced groups indoors when possible, and HPS became one of the few activities that children could continue during pandemic isolation. Given more time for practice, great parental support, and the innovation of private lessons online, children's technique blossomed. Family 'bubbles' created ensembles. Middle School boys continued drumming over the summer so that they would have a way to safely get together and creatively vent. HPS may be one of few organizations that flourished and improved children's mental health and music skills during the pandemic. As a result, the people of Sooke are asking it to grow—again.

Project description

Months before the COVID-19 pandemic, thousands of young people living on the traditional lands of the Lak waŋan peoples descended on BC's Legislature to raise their voices about protecting the planet. In the Capital Regional District, as elsewhere, the intersecting threats due to the catastrophic socio-economic impacts of the COVID-19 pandemic and the unfolding environmental and climate emergency have significantly impacted the rights of children.

To amplify young people's voices and shine light on these issues, IICRD is teaming up with the David Suzuki Foundation and the Children's Environmental Rights Initiative (CERI) (and others) to host the first ever virtual intergenerational consultation on the rights of children and youth to a healthy environment for the North American region, in partnership with the UN Special Rapporteur on Human Rights and The Environment, David Boyd. This virtual initiative, called the "Phoenix Consultation", is scheduled to take place in July 2021. Through our Child Thrive program, IICRD is requesting support from the Capital Regional District (CRD) to engage children (ages 5-12) in the Greater Victoria Area to contribute to these consultations through the power of the arts, including: puppeteering, music, images (incl. drawings, photography, clay, etc.), and videography. This project will involve four core elements to:

- 1. Engage a local puppeteer to create a digital story for inviting children from the CRD to share art (drawings, music, poems) about their ideas related to children's right to a healthy environment. The puppeteer may 'interview' 4-6 children about their ideas while visiting local playgrounds.
- 2. Outreach and coordination to collect arts-based images from local children (targeting 20-30 submissions). This may include reaching out to community groups (community associations, boys and girls clubs, etc.) and ensuring safe collection of drawings for showcasing (e.g. coordinating assent/consent forms). Local eco-prizes will be drawn to celebrate entries based on age categories (e.g. passes to Victoria Compost Center).
- 3. Collaboration with a local songwriter/singer to re-vamp a song for the Phoenix Consultations, including the possibility of featuring local children's voices.
- 4. Coordinating with a local technical editor to create a simple video for sharing highlights of the children's artwork with the song produced. The video will be shared during the North-American wide consultation, to enable children's voices to be heard. While some youth leaders (up to 100) will be able to participate in the virtual consultations, IICRD would like to create opportunities for children, including at least 20-30 from the CRD, to share their perspectives to help 'raise their rights' for a healthier environment through the arts.

Past years have included visual art showings, digital media and film screenings, markets, educational talks, dance, and cultural presentations. One Wave Gathering has grown into an important event for the South Pacific diaspora and for local Indigenous communities. Indigenous artists and participants have shared feedback that they love this event and see it as a safe and inspiring program to engage in building understanding, as we showcase and celebrate Pacific and Indigenous arts and cultures. Last year we organized a very successful Orange Shirt Day First Nations market and cultural event at Royal Beach in the western communities. Despite the challenges brought on by COVID-19, we were able to provide inspiring and safe programming to the community.

We are committed to a process of in-depth community consultation that guides all events and programming. For example, we changed the name of our event in 2017 from One Wave Festival to One Wave Gathering as guided by Songhees Elder Skip Dick. He helped to reshape this from "entertainment" to what is now an award-winning Pacific celebration and gathering of friends and cousins. We continue to maintain close contact with local Indigenous advisors and gather testimonials after each One Wave Gathering to ensure relevance, value, and accessibility of activities. Given the constant irregularities as a result of COVID-19, our plan for One Wave 2021 is to be dynamic and thus safe for everyone who attends or participates. This means strictly abiding by provincial health protocols and adapting our programming as needed.

Comments on the Recommendation

Pacific Peoples' Partnership Assn

This application scored well above the level to fulfill the goals and intended outcomes of the IDEA grant program. The requested grant was only 3% of its cash requirements and the recommendation for slightly less than the requested amount is anticipated to be sufficient for the project to be produced successfully, and will allow funding to be provided to other applicants at this deadline.

After the inaugural apple event, held with Covid social restrictions, it seemed there was a great need and desire for community connection and engagement.

At the event community members had a sense of renewed hope and energy while being involved in working together in a Covid safe way. It was an important way to reintroduce connection in the community, a way to promote mental health and well being and the importance of our own food security on Pender and the learning of new skills furthering sustainability. By adding an arts component provides a big gateway to improving mental health. Music, especially, is a great vehicle through which to connect people, to build community. Building community through music and other art genres led to "The Crisp" idea.

Project description

We are seeking funding for our Creative Arts Program. This program takes a holistic approach to recovery by empowering brain injury survivors to use the creative process of art-making to improve and enhance their physical, mental and emotional well-being. The creative process involved in artistic self-expression helps survivors work through challenges, develop interpersonal skills, manage behavior, reduce stress, increase self-esteem and self-awareness and achieve insight. Using art as a vehicle of exploration and healing, the Creative Arts Program utilizes different materials through which a survivor can express themselves, including drawing, painting, clay and visual arts.

The Victoria Brain Injury Society's basic philosophical underpinnings are rooted in the idea of maximum independence with minimum professional supports. Our Creative Arts Program is designed to foster this independence through a variety of different strategies. As survivors often experience extreme loneliness and depression and can become isolated from family, friends and the broader community, this program is designed to foster the development of a healthy environment for brain injury survivors, where they can thrive as individuals and grow together in the community.

The program provides a safe environment for survivors to gain new skills while learning to deal with the challenging impacts of their injury. Learning expression through creative arts can help reverse the losses experienced by survivors, and increase the individual's ability to cope and rehabilitate themselves. This will have a ripple effect on the broader community, as these supports will mean survivors will be far less likely to experience family breakdown, have substance abuse problems or become homeless.

Victoria Women's Transition House collaborates, advocates and educates to address and prevent intimate partner violence and abuse of women and children through supportive shelter, housing, counselling and other community-based services.

Project description

UN Women, the United Nations entity dedicated to gender equality and the empowerment of women, labels violence against women and girls amid COVID-19 the "shadow pandemic." They state in their April 2020 report that "in times of crisis, violence against women and girls is likely to increase as security, health, and money worries heighten tensions and strains are accentuated by cramped and confined living conditions."

When examining the COVID-19 impact, StatsCan reports that 1 in 10 women is very or extremely worried about the possibility of violence in the home. Since the start of the pandemic, violence against women has intensified, and demand for our services has increased by approximately 30% across all programs.

For the older women supported by VWTH who are survivors of intimate partner violence and abuse, the ongoing isolation and added hardships caused by COVID-19 have compounded existing stresses and threatened the healing and resilience they are working so hard to achieve. Women who have participated in past Healing Through the Arts programs have repeatedly expressed in feedback and evaluations that access to safe, creative exploration in a highly supported group setting with guidance and encouragement from professional artists and counselling staff is a vital component for building and maintaining resilience. Integrating feedback and experiences from women who have experienced the power and benefits of participating in an art-making program assisted by wrap-around supports, Healing Through the Arts: Creativity and Resilience Through COVID-19 will incorporate: Activities that encourage self-exploration, mindfulness and intuitive and expressive art making. Exploration and experimentation in a range of engaging media that inspires and challenges, such as art journaling, writing, painting, drawing, mixed media and ceramics.

Opportunities to learn new art-making skills in a range of media to build confidence and resilience. Integration of new areas of creative exploration that promote diversity through artist contribution and their art making practice. These may include explorations of printmaking and weaving, both as techniques/areas of artistic practice as well as activities that promote focus and reflection. A collaborative art project created by participants to share within their community.

Safe opportunities to reflect on and share artworks and experiences through displays, anthologies and other activities. Healing Through the Arts: Creativity and Resilience Through COVID-19 will allow VWTH to reach out to older women suNivors of abuse - an underseNed demographic in Victoria, now even more isolated due to the pandemic. This program will run in two groups: Group #1 will run once per week for eight weeks from midOctober to early December 2021 and will focus on visual arts, journaling, poetry and spoken word sessions. Group #2 will run once per week for eight weeks from mid-January 2022 to late March and will focus on printmaking and ceramics. All sessions will last for two hours, plus prep and clean up. With participants' permission, art will be displayed on-site at the Arts Centre at Cedar Hill. The program will be evaluated at the conclusion of each of the two eight-week sessions through analysis of group attendance, participant surveys, as well as artist and counsellor feedback. We anticipate that this program will impact 16-20 survivors of intimate partner violence.

Healing Through the Arts: Creativity and Resilience Through COVID-19 will have a significantly positive effect on participants as they use their new skills and confidence to engage with others in shared interests and experiences, relieve isolation by participating in community-based activities and develop time for safe, quiet reflection and resilience as they heal from intimate partner violence and abuse.

***NOTE: Should COVID-19 protocols limit face-to-face interaction, this project can be adapted to online delivery with each session offering group and individual video/digital support from the VWTH older women's counsellor, and instruction and guidance from each of the professional artists. With careful safety guidelines, a package of art materials can be delivered to each participant along with instructions regarding the digital program

and online delivery times.

ARTWORKS@VICHIGH would see students and staff collaborate with local artist Tanya Bud (tanyabud.myportfolio.com) to create culturally relevant art to be displayed at VIC High with community access. Tanya and students will be working in 2 art mediums, namely driftwood and papier-mâché.

The initial goal is to present 2 to 5 life sized art sculptures to feature prominently at Vic High's (VHS) grand reopening, September of 2022.

Phase 1 – June 2021. The goal - establish ARTWORKS' parameters and liaise with students and staff leading to various designs of 5 life sized figures representing VHS's heroes, visionaries and scoundrels.

Phase 2 -Sept. 2021 to May 2022–The student's chosen heroes, visionaries and scoundrels will come alive under the tutelage of Tanya Bub as they start designing life sized papier-mâché and driftwood figures.

The first life sized sculptural exhibit is envisioned to be of VHS student and internationally renowned icon, Emily Carr.

Phase 3 Construction and positioning of two to five ARTWORKS ready for placement Sept. 2022.

The project organizers intention is to pay homage to VHS's School history and cultural diversity within the scope of ARTWORKS that would include students and staff from conception and execution.

VSPS approached Tanya Bub. Fascinated, she committed to ARTWORKS@VICHIGH. VHS principal, Aaron Parker and vice principal Christopher Koutougos followed suit.

The art medium she favours, driftwood and papier-mâché are perfect as they are accessible and inexpensive. The organizers are excited, original art is found usually in art galleries and private homes, not accessible to the public.

ARTWORKS@VICHIGH will inspire by exposing CRD citizens to new and amazing art. Moreover it is designed to be changed up every three years to reflect the sensitivities of changing student populations.

SUBJECT: 2021 Equity and Incubator Grant Recommendations

ISSUE SUMMARY

The 2021 Equity Grant and Incubator Grant recommendations are presented for Arts Commission review and approval.

BACKGROUND

The Equity and Incubator Grants programs became core funding programs in 2021.

Equity Grants are intended to support applicants that face systemic barriers to accessing support through other CRD Arts and Culture Service funding programs. Equity Grants are unique among CRD funding programs as it allows a not-for-profit society to function as a "Sponsor Society", on behalf of an equity-seeking applicant that is not itself a society. In order to provide the broadest possible access the program also allows equity-seeking applicants to self-identify.

Incubator Grants are intended to enhance sustainability and resiliency in the arts by funding short-term staffing, mentoring, workspace, training or other resources that assist in the acceleration of organizational development or, in the development of new arts projects. They are aimed at emerging or established organizations with an arts mandate.

An adjudication committee assessed five Equity Grant applications and two Incubator Grant applications. Applications are assessed using a scoring matrix reflecting the goals and intended outcomes of the respective programs. The resulting aggregate scores provide a comparative assessment of each organization's proposal as it relates to the purposes and goals of each program.

The adjudicators assessed the Equity applications using assessment criteria according to the published guidelines as follows:

- The identified group or organization leading the project
- The proposed project
- The benefits and impacts for the group, their community and the regional community
- An understanding of the intended audience
- Partnerships or collaborations
- Budget and projected expenses and revenues

Each Equity application was scored and were assessed to be at a level that merited support. Each of the five applicants were recommended for their full request for a total of \$25,000.

The jurors then assessed the Incubator applications using the criteria for that program as follows:

- Program description
- Key personnel
- The anticipated development of capacity within the organization as a result of the project
- skills or development for personnel
- Creation of partnerships
- Impacts for the art form and the community

• Budget and projected expenses and revenues

Both applications were scored and assessed to be at a level to merit support. Both applications are recommended for their full request for a total of \$9,000.

The results of the adjudication were presented to the full Arts Advisory Council for discussion. The results were ratified and then recommended for consideration of approval by the Arts Commission. Summary pages are provided for each application and are attached to this report.

ALTERNATIVES

Alternative 1

The Arts Advisory Council recommends to the Arts Commission:

- 1. That the \$25,000 in 2021 Equity Grant recommendations be approved as presented; and
- 2. That the \$9,000 in 2021 Incubator Grant recommendations be approved as presented.

Alternative 2

- 1. That the 2021 Equity Grant recommendations be approved as amended; and
- 2. That the 2021 Incubator Grant recommendations be approved as amended.

Alternative 3

That the recommendations be referred back to the Arts Advisory Council for further information.

IMPLICATIONS

A total of \$35,000 was available for Equity Grants and Incubator Grants. A total of \$25,000 in Equity funding is recommended and a total of \$9,000 in Incubator Grants is recommended for a total of \$34,000. \$1000 remains in the budget which, if unspent at year-end will be transferred to reserve.

CONCLUSIONS

A total of seven proposals are recommended for Equity and Incubator grant funding. The recommended projects fulfil the desired purpose and outcomes of the respective grant programs.

RECOMMENDATION

The Arts Advisory Council recommends to the Arts Commission:

- 1. That the \$25,000 in 2021 Equity Grant recommendations be approved as presented; and
- 2. That the \$9,000 in 2021 Incubator Grant recommendations be approved as presented.

We are requesting funding to support the development, production, and dissemination of a new contemporary arts publication entitled Wrought Journal. This edition of the publication will be our first issue, and the springboard for an ongoing project that we will continue to produce semi-annually. We will be collaborating with visual artists residing within the CRD as well as selected artists living internationally to be featured in this work, and are requesting funding to produce 150 copies of this initial issue while supporting all participating artists with compensation in accordance with CARFAC standards.

The overall goal of this project is to magnify the thought-provoking practices of female and non-binary artists who are imagining new ways of engaging with visual art through an inclusive, feminist lens. This issue will employ the theme of surveillance as a unifying framework, and proposes a creative re-imagining of associations with state scrutiny. Die cut holes throughout the publication will focus on gaps in understanding, those who are overlooked, and portals to individual experience. In shifting the lens away from an authoritarian structure, the issue will highlight visual approaches to ideas that centre on possibility and imagination rather than oppression.

There are two main activities for which we are seeking funding: the first is to pay participating artists publication funds in accordance with CARFAC standards, and the second is to produce and print 150 copies of this initial edition. We will be distributing these journals to local CRD arts organizations and to individuals within the community.

Noble Riot Dance Theatre is requesting funding to help support the development of our new contemporary dance company. For it's first season, NRDT will focus on three areas:

- 1. Creation of new works
- 2. Free public performances throughout the Greater Victoria area
- 3. Research & Development in Grant Writing Skills

NRDT will support Artistic Director Kayla Henry in the creation of three new solo works. These works will be created and performed by Kayla. She will require 100 hours of studio space, and for part of this process, she will be working with a mentor and an understudy.

These short solos will be presented as a series of pop-up art installations called *Body Poetry* in site specific venues throughout Victoria. These venues include common spaces at assisted living facilities, low-income housing complexes, BC Cancer Care, and parks and beaches. If required, we will ensure all required permits are pulled. We aim to present *Body Poetry* on the first Friday of each month, running June-September 2021. These events will be documented and used as support material for grant applications for the BC Arts Council, and Canada Council for the Arts.

One of our core values is to make dance accessible and to remove barriers that may otherwise prevent people from attending shows that are in a theatre setting and at a cost. With this in mind, and to build a new audience for the company, we will focus primarily on free outdoor performances for our first season. With respect to grant writing, it is imperative for NRDT to acquire skills and knowledge about the funding
