7. Staff Report: Designated Communities Investment Plan & Funding Priorities

CRD staff have been informed by the Government of Canada of potential upcoming increases in funding to the Reaching Home program. Even though the proposed increase still needs parliamentary approval, in order to expedite mobilizing the funding, the CRD as Community Entity wishes to prepare a Call for Proposals. CAB members considered a report from CRD staff outlining an updated Investment Plan and offering options for setting specific priority program areas to direct any proposed new funding.

Motion to approve the Investment Plan presented by CRD staff; recommend Reaching Home staff to extend existing Sub Project Agreements that expire on March 31, 2022 providing incremental increases to address cost escalations in the programs; and recommend staff develop Call for Proposals documents based on the priorities identified.

8. Program Updates

a) Coordinated Access and HIFIS

Community Planner provided CAB members with update on work plan presented to the CAA Advisory Committee and the plan to form two working groups for implementation of Coordinated Access and HIFIS in the region.

b) Reaching Home

1) Community Homelessness Report

ESDC requires the Community Homelessness Report be submitted by CE's before June 30, 2021. CRD staff informed CAB members on process for data collection and how the implantation of HIFIS will increase overall data the CE is able to report on in the future.

2) COVID-19 Update

Reaching Home COVID-19 Administrative Coordinator provided summary to CAB on the 25 contracts managed through the pandemic, including three with First Nations to support capital projects. A great deal of the \$3.1 million of funding provided through the Designated and Indigenous streams went to basic needs, prevention and shelter diversion.

3) Administrative Update

Reaching Home Program Coordinator updated CAB members on staffing changes within the department. The CE also recently submitted a report on Project Details to ESDC. Currently the CE is managing 10 sub projects, 7 under Designated Communities and 3 under Indigenous Homelessness.

9. Coordination of Shelter, Housing and Services (GVCEH)

Kelly Roth provided details on engagement and research ongoing by GVCEH staff and how it supports the Community Plan. Once health regulations allow GVCEH is planning to host an engagement between GVCEH Board and Reaching Home CAB, targeting Fall 2021.

10. Update on Indigenous Homelessness CAB

ESDC updated the CAB on progress towards creating an Indigenous CAB (ICAB). Members have come forward and the first meeting is scheduled for May 28, 2021. Cyril Morris has agreed to act as a liaison between the Designated Communities CAB and the ICAB. The ICAB members would like broader outreach with Indigenous community groups, and will begin work on Terms of Reference and discussing future direction of Reaching Home Indigenous Homelessness.

Next meeting will involve a review applications for the call for proposals and update from GVCEH on engagement between the GVCEH and CAB. Tentative date is September 23, 2021 9:00-11:00am.
