Regarding item 6.5 on the agenda, he indicated that he would propose at that time to postpone consideration of the matter, so that strategies could be sought on how to continue the efforts towards full participation.

# 6.1.1 Arts Advisory Council Chair's Report (Verbal)

Chair Heiman reported that the Council had met earlier in the month, and had elected Rachel Ditor as the Funding Chair, to take over the term vacated by M. Heinz. She provided highlights of R. Ditor's arts background and jury experience. The regularly scheduled Council Chair and Funding Chair elections take place in January.

The Council discussed the Equity, Diversity and Inclusion (EDI) sub-committee Terms of Reference at their September meeting. Chair Heiman thanked the Commission for their faith in the Council for carrying out that work. She reported that six members of the Council volunteered to sit on the sub-committee.

In conclusion, she remarked that adjudication for the operating grants will take place in November, for recommendation to the Commission in January, 2022.

- Potential changes in service levels regarding 100% participation: If the Commission opted to change the level of service, the process would be through updates to the service plan and be reflected in the budget.
- Whether the lack of 100% participation could be brought to light in the trends, risks and issues section of the service plan: Participation could be demonstrated in the section on scope of service, using language such as "9 out of 16 jurisdictions participate."
- No new initiatives listed for 2022: Means there are none that need new resources for work planned for 2022.
- Progress on the strategic objectives: Objective 3(b) is the work on equity, diversity and inclusion. Once the subcommittee has completed its work, the resulting equity lens will inform the other objectives.
- Possible ways in which the next Arts and Culture Strategic Plan could be aligned to the next CRD Corporate Plan.

- At the Board meeting, there were strong comments from some Directors that an AAP could open the door to other service expansions that would not benefit the jurisdictions they represent.
- There are three types of approval processes allowed by legislation; the AAP type can be described as a counter-petition process. A second type is a referendum, requiring polls and voting. The third process is consent on behalf of electors, in which municipal councils can resolve to consent on behalf of the electors, and an Electoral Area Regional Director can consent on behalf of the Electoral Area.
- Bylaws for establishment of amendment of a service are written to describe the approval process for the bylaw and participants of the service, and would need to be rewritten and the approval process started again if the approval process is not used or a participant drops out.
- The Chair will call a meeting in the near future.

# 6. Manager's Report

As requested, C. Gilpin provided a review of the recent work by staff, and CRD Board outcomes, regarding region-wide participation in the Arts & Culture Service, for the benefit of new members.

The CRD Regional Impact Award was presented at the recent Regional Arts Awards held in Sidney at the Mary Winspear Centre. Puente Theatre and Intrepid Theatre jointly received the award for their project, "Converge". The project included a residency and mentorship for BIPOC artists.

The 2022 Arts & Culture budget was endorsed by the Arts Commission at their September meeting. The Operating grant portion, available to the organizations applying this fall, includes

an increase of \$53,230 for a total of \$2,281,230. He noted that no new clients applied to the operating program and no directive was given by the Arts Commission for the disbursement of the additional funding.

Staff thanked members for participating in the ongoing work and acknowledged staff for their work in supporting the acitivities of the AAC. It was noted the Operating grant packages are still on schedule to be sent to AAC members on Oct 14<sup>th</sup> or 15<sup>th</sup>.

Terms of Reference

# 1. Purpose

#### a) Mandate:

On October 28, 2020, the Arts Commission passed a motion:

"That the Arts Commission commits to an equity lens to operations and granting... That staff be directed to draft terms of reference for an Equity Advisory Sub-Committee to explore grant adjudication, accessibility of information, data collection and the development of an equitable access policy for all arts funding programs." 1

The 2020-23 Strategic Plan for the Arts and Culture Support Service also commits to Make Access Equitable. This strategic direction aims to "Increase representation of art forms funded by the CRD" and to:

- 3a) Ensure support for new and emerging organizations.
- 3b) Support equity, diversity and inclusion through grant programs.
- 3c) Reduce barriers experienced by rural communities.

#### 2. Definitions

- a) Equity refers to achieving parity in policy, process and outcomes for historically and/or currently underrepresented and/or marginalized people and groups while accounting for diversity. It considers power, access, opportunities, treatment, impacts and outcomes, in three main areas: representational equity, resource equity, and equity-mindedness.
- Equity-seeking communities are those that experience significant collective barriers in participating in society. This could include attitudinal, historic, social, systemic and environmental barriers based on a number of grounds.
- c) Diversity refers to differences in the lived experiences and perspectives of people that may include race, ethnicity, colour, ancestry, place of origin, political belief, religion, marital status, family status, physical disability, mental disability, sex, gender identity or expression, sexual orientation, age, class, and/or socio-economic situations.
- d) Inclusion is an active, intentional, and continuous process to address inequities in power and privilege, and build a respectful and diverse community that ensures welcoming spaces and opportunities to flourish for all.

#### 2. Roles and Responsibilities

The Sub-Committee will:

- a) Provide guidance and advice to the Arts Advisory Council on matters related to equity, diversity, and inclusion;
- b) Make recommendations in the development of an equity, diversity and inclusion lens to apply to operations and granting programs of the Arts and Culture Support Service with a focus on

- adjudication, accessibility of information, data collection, and the development of an equitable access policy; and
- c) Conduct outreach or consultation with individuals or groups from equity-seeking communities to better understand their perspectives and needs regarding arts and culture support, and their aspirations for arts and cultural development in their communities.

# 3. Composition

- a) The Sub-Committee membership will be established by a call for volunteers at the Arts Advisory Council.
- b) The Sub-Committee will nominate and elect its own Chair and Vice-Chair at its first meeting.
- c) The Sub-Committee may recruit members from the wider community, who are not members of the Arts Advisory Council, on an invitation basis to bring diverse perspectives and lived experience to the Sub-Committee.
- d) As per 4(d) of the AAC establishing bylaw 2973, membership must consist of a majority of AAC voting members.
- e) The Sub-Committee may consist of no more than 12 total voting members.
- f) Staff of the Arts and Culture Support Service will attend meetings and participate as ex-officio Sub-Committee members to provide administrative support, points of information, and other resources, as necessary.
- g) Terms of appointment shall be to a maximum of eight (8) years with:
  - The first term to be for one (1) year,
  - ii. The second term to be for up to three (3) years, and
  - iii. Subsequent terms to be for up to two (2) years.

## 4. Procedures

- a) The Sub-Committee will meet on a monthly basis, or at the call of the Sub-Committee Chair for special meetings, as the need determines.
- b) The Sub-Committee will meet in person or through videocall, or a combination of the two, as abilities and circumstances warrant.
- c) The Sub-Committee will strive toward a consensus decision-making model, where possible.
- d) Each Sub-Committee member has one vote. Arts and Culture Support Service staff are ex-officio members and do not have a vote.
- e) Quorum is 50% of the Sub-Committee membership. Quorum is required for any motions to be proposed at a meeting.
- f) Motions will be carried if 50% plus one of members vote in favour. If there is an equal number of votes for and against, the motion fails.
- g) The Vice-Chair will perform the duties of the Chair, if the Chair is not available. If neither the Chair, nor Vice-Chair are present at a meeting, the Sub-Committee may designate an Interim Chair for that meeting.
- h) The Sub-Committee shall be conscious of and sensitive to the issues of conflict of interest. A Sub-Committee member who perceives an issue of possible conflict of interest of their own will raise it. The matter will be discussed and then resolved by the members of the Sub-Committee

who may direct the member to absent themselves, impose specified limitations on the member's involvement, or conclude that no action needs to be taken.

# 5. Resources and Support

a) The staff of the CRD Arts and Culture Support Service will provide administrative support to the Sub-Committee, where requested, including taking minutes, coordinating outreach, drafting reports, and other administrative logistics.

## 6. Reporting

- a) The Chair of the Sub-Committee will provide verbal reports to the Arts Advisory Council as a standing item on the agenda of the Arts Advisory Council regular meetings.
- b) Any policy recommendations from the Sub-Committee will be transmitted to the Arts Advisory Council as a written report.
- c) All policy recommendations require endorsement from the Arts Advisory Council and final approval from the Arts Commission before they can be implemented.
