REPORT TO PENINSULA RECREATION COMMISSION MEETING OF THURSDAY, NOVEMBER 25, 2021

SUBJECT Enabling Accessibility Fund– Small Projects Component

ISSUE

To inform the Commission of the outcome of the Enabling Accessibility Fund (EAF) grant application

BACKGROUND

In September 2021, Panorama Recreation, in partnership with Sooke and Electoral Area Parks and Recreation Commission (SEAPARC) staff, were notified of their successful application to the EAF for \$100,000 to improve community accessibility at both facilities.

The EAF provides funding for eligible capital projects that increase accessibility for people with disabilities in Canadian communities and workplaces. It creates opportunities for participation in community activities and programs and services.

Utilizing the Rick Hanson Foundation score card for facility accessibility that was completed in 2019, staff were able to identify key priorities for accessibility upgrades. The approved upgrades to Panorama and SEAPARC include: accessible automatic doors, toilets, sinks, faucets, soap dispensers, braille signage, paper towel dispensers, emergency call buttons, mirrors and grab bars.

No matching funds are required. The proposed project start date is October 27, 2021, and the end date is October 26, 2023.

IMPLICATIONS

Social Implications

Infrastructure improvements including installation of automatic doors and enhancing washrooms to improve accessibility would significantly improve the ability for people of all abilities to attend recreation programs and services at Panorama Recreation facilities and would improve the feeling of belonging within their communities.

Financial Implications

The cost of the project is estimated at \$100,000 which is funded in part by the Government of Canada's EAF and does not require additional funding from the operating or capital budgets.

Service Delivery Implications

There are diverse populations attending Panorama Recreation facilities, including participants from group homes, community members requiring 1 on 1 support, sport organizations with varying abilities, community members with mobility challenges and instructors or staff with varying abilities. The facility accessibility improvements will largely improve their experience accessing Panorama Recreation facilities, and in return, increase participation.

CONCLUSION

Panorama Recreation and SEAPARC were successful in their application to the Enabling Accessibility Fund for \$100,000 to improve facility accessibility. Infrastructure improvements will positively impact a diverse range of users at Panorama and SEAPARC.

SUBJECT Teen Programs and Services Report

ISSUE SUMMARY

To provide an update on the restart and next steps of Teen Lounge and other preteen/teen programs

BACKGROUND

The Panorama community recreation department strives to deliver high quality programs for preteens and teens on the Saanich Peninsula. As a result of the pandemic, many youth and teen programs were suspended for nearly 18-months (March 2020 – September 2021) which left a void in services for youth in the community. As the community has learned to adapt to the current health crisis, services are being reintroduced to meet the needs of those youth.

Prior to the pandemic, Panorama was offering 360 hours of free teen programming as per the 2016-2019 service plan. Programs offered included Friday and Saturday night Teen Lounge (average attendance of 42 teens/night) at Greenglade Community Centre and Central Saanich Boys and Girls Club, teen skates and swims on Friday evenings at Panorama, and registered leadership programs such as Babysitters Training and Home Alone.

Beginning in September 2021, staff reopened the Teen Lounge on Tuesday and Friday evenings (6-8pm) at Greenglade Community Centre. The focus of these two program offerings is to reintroduce ourselves to the community and provide an option for youth/teens to participate in a safe, social and active program with their peers. Tuesday evenings are a more relaxed program offering, focusing on building relationships with the participants. The smaller attendance numbers allow staff to build stronger relationships and focus on more complex activities (board games, craft projects, homework support, etc.). On Friday evenings, attendance is already matching and exceeding pre-pandemic levels with an average attendance of 53 participants each night. This larger group has exclusive access to the entire Greenglade Community Centre with gymnasium activities, video games, special events, and general socializing. For those interested, as part of the Friday Teen Lounge, staff provide free shuttle service to Panorama Recreation where youth are given free access to attend a supervised teen skate or swim. Average attendance in the Friday teen skate has been 150 youth participants each night.

IMPLICATIONS

Social Implications

Throughout the pandemic social connections were dramatically reduced and numerous reports have stated that the mental wellbeing of children and teens has been particularly impacted during this time. Now that teen programs are returning, we can provide safe opportunities for increased social connections and normalcy. Our staff are able to build relationships with the teens attending, assisting staff to make informed programming decisions to meet participant needs now, and for future seasons.

Financial Implications

By hosting these programs for free or at a low cost, we are removing a large barrier for participation in these activities. For the approximately 50 hours of free Teen Lounge programming during the Fall 2021 season, the staffing cost is approximately \$3,460.

Service Delivery Implications

As we continue to move ahead and through the pandemic, staff hope to increase the programming options available for teens. Looking ahead to 2022, staff plan to offer the following new opportunities:

- Teen Tours will provide youth ages 11-16 with the opportunity to participate in an age appropriate adventure camp on scheduled school non-instructional days. Under the supervision of a Panorama staff member, teens will be transported to various locations across the island to take part in everything from wacky fun at the trampoline park to learning wilderness survival skills at local parks. Teen Tours will also run sessions throughout spring and summer break.
- Teen Lounge will offer special event nights once per month. Special events will range from karaoke and talent shows, to board game and bingo nights. All events will be free of charge for youth to attend.
- In partnership with the fitness department, staff will be looking to offer teen fitness classes/ and supervised weight room times. Popular fitness classes such as interval training or spin classes will be catered towards youth aged 12-18. These programs will be designed as an introduction to fitness, and allow youth to engage in a regular healthy activity with friends/peers.
- Aimed to open around the completion date of the new multi-sport court, staff plan to offer teen drop in sport leagues. Through the strategic plan youth survey, it was identified that accessible sport opportunities are desired by our community youth. Drop in sport leagues will be staff supervised programs, designed to introduce youth to new sports as well as facilitating regular games of their favourites.
- Staff plan to extend existing Friday night Teen Lounge hours from 6-8pm to 6-9pm which will allow staff to better implement events and activities as well as provide youth with an alternative option should they not wish to travel up to Panorama Recreation Centre for swimming and skating.

CONCLUSION

The Teen programs are an effective way to give youth an active, supervised space during the school year to build relationships with their peers and a sense of belonging in their community. Over the upcoming year, staff will work to return free youth/teen offerings to pre-pandemic levels while also offering new program options.
