# REPORT TO SOOKE AND ELECTORAL AREA PARKS AND RECREATION COMMISSION MEETING OF TUESDAY, FEBRUARY 01, 2022

#### **SUBJECT** Programs Services, Administration and Operations Update

#### **ISSUE SUMMARY**

To provide the Commission with an update on SEAPARC programs and services.

#### **BACKGROUND**

#### **PROGRAM SERVICES**

The past month has brought challenges with additional pandemic orders resulting in capacity limits and partial facility closures implemented by the PHO, and as anticipated the Omicron variant brought a rise in staff illness that impacted programs and operations. Staff continue to adapt and modify schedules to mitigate the impact of services for the public.

SD62 postponed all indoor user group and community usage until January 31, in an effort to keep schools operational to support student learning. The current increase of sickness and absenteeism in the schools, the possibility of functional closures due to District wide staffing shortages, and the added pressure placed on the custodial team to maintain enhanced cleaning requirements are all contributing factors leading to this decision made by District Leadership. Staff are in regular contact with the school district to keep apprised of any changes.

Family Day is on Monday, February 21. SEAPARC will be open reduced hours for the pool, weight room, public skating and ice user groups. Staff applied for the BC Provincial Government Family Day Grant to support a free family skate.

#### **Community Recreation and Arena Programs**

Select Community Recreation programs including Pickleball, Engineering for Kids and Taekwondo are postponed until access is again permitted in the schools. There are no alternate locations for these programs to run at this time.

#### **Weight Room and Fitness Programs**

The weight room and fitness programs experienced a four-week closure and were permitted to reopen on January 20 with a capacity limitation of 7 square metres of useable floor space per patron to a maximum of 25 people per workout room/space and reserved time slots. The weight room hours of operation have been extended on the weekends.

#### **Aquatics**

The Canadian Red Cross announced it will no longer offer swim lessons in Canada, and will focus on humanitarian aid. SEAPARC will transition to the Lifesaving Society's Swim for Life program in 2023. Swim for Life was launched in 2002 in many parts of the country, and staff are confident this program will continue to meet the needs of our community. Over the next few months, steps will be taken to ensure a smooth transition for SEAPARC's lesson program.

#### **ADMINISTRATION**

#### **Golf Course**

The golf course is currently in seasonal closure. SEAPARC golf service levels will be reviewed for 2022. If schedule or fee changes are recommended, they will be presented to the Commission for consideration.

#### Bike Park

The bike park jumps are currently closed for seasonal repair and maintenance and will reopen in March when maintenance is complete and weather permits.

#### **Sport Box**

SEAPARC staff are currently working on operational plans to prepare for a spring 2022 opening.

#### **OPERATIONS**

#### **VIHA Vaccination Clinic**

The vaccination clinic resumed operations at SEAPARC on January 18, occupying the multi-purpose rooms. The clinic is open 11:30am- 6:10pm, Tuesday to Saturday.

#### **Pool Chlorination System**

Work continued with the consultant to certify the configuration and capacity of the new system. The tender for the new chlorination system is expected to be released February 1, 2022.

#### **IMPLICATIONS**

#### Social Implications

The benefits of recreation are far reaching and are essential to a healthy community. Despite the reduction in services during the COVID-19 Pandemic, SEAPARC continues to provide and adapt programs and activities that provide participants opportunities to be active within their community.

#### Financial Implications

The Provincial Health Order regulations that pose partial facility closures and attendance limitations for programs and activities continues to have potential impact(s) on projected financials. Staff shortages have also impacted the ability to offer some services and programs. Staff continue to monitor and adapt services to ensure fiscal responsibility.

#### Service Delivery Implications

Staff continue to adjust service delivery to meet Provincial Health Order restrictions. As the health orders change, staff adapt services accordingly to continue providing a safe, quality experience.

### CONCLUSION

SEAPARC continues to monitor and adjust operations in response to current health restrictions and changing regulations.
