a) Email dated 10/10/2022 from Ruby Bandechha – Tobacco Enforcement officer / Reduction Coordinator regarding CRD Clean Air Bylaw # 3962 and cigarette butt receptacles in the Disc Golf Park. It was requested in the email that the receptacles be removed from the Park as per the no smoking in Parks Bylaw. The commissioners discussed this at length, noting that the Fire Chief has asked for receptacles be placed at trail heads to prevent cigarettes being discarded on trails as they can be a fire hazard. It was also noted that the users of the Disc Golf Park are not only people playing Disc Golf but some people just like to relax there and have always been very respectful of putting their butts out in the receptacles provided. Commissioner Tretrick offered to take pictures of the existing signs and speak with the Fire Chief and CRD Bylaw offer to see what they recommend. Commissioner Frick also offered to speak with the Disc Golf users group to see how they would like to proceed. The commissioners will speak to this again after all groups have been spoken with.
