## 6. PRESENTATIONS/DELEGATIONS

Keith Erickson from the Galiano Activity Center Society (GACS) joined the meeting and reported that GACS plans to replace Galiano's existing public wooden tennis court with an ashpalt court . GACS is seeking a partnership with GIPRC where the capital costs are borne by GACS and PRC funds maintenance. Estimated costs are \$2000/year. GACS is seeking capital funds from EBCM and BC Gaming. Commissioner Henschell thanked Mr. Erickson and requested a written submission outlining the case for support.

## 7. ADMINISTRATION REPORTS

7.1 Maintenance Contractor's Report: Circulated prior to the meeting. The neighbour-installed Retreat Cove gazebo is threatened by erosion and Michael Carrothers asked the Commission to consider another location for the gazebo. Commissioner Longson and a contractor friend will visit the Gazebo to assess its condition as part of GIPRC's Asset Management Plan.

Two dead trees near Skate park require falling but are located on private property. Emma will explore options for danger tree removal and connect with Michael Carrothers Commissioner Henshall will reach out to the homeowner where trees are located.

Erosion at Dewinitz and Morning Beach are notable and repair/replacement of rock stairs will be discussed at a future Commission meeting. Michael Carrothers will reach out to Rene Zich, local mason, for information and suggested contractors.

Replacement metal stairs for #23 Ocean View are being fabricated by Michael Ash.

Zuker restoration has enjoyed volunteer support from UVIC students and local volunteers, valued at \$28,000. Plant orders nearly finalized: on track to spend \$6K from the TD grant within the required timeline and completed the impact report for TD grant. Michael is putting in additional hours to prepare Zone 2 and Zone 3 for the planting event schedule for the weekend of November 26th. \$6K residual for the project in 2023. Budget bolstered w additional \$9K to complete consultation process and implementation of infrastructure in 2023.
