a. Discussion of name for new park and signage (Robyn) – trail across from Money Lake. Suggested "West Ridge Trail" as a working name, open to a First Nations name and blessing. ACTION: Rosemary to organize sign with big wooden round base "West Ridge Trail".

- b. Refinishing picnic table tops (Robyn)- Saturna Beach picnic table needs refinishing. After discussion it was determined to be a spring job due to drying temperature of varnish. ACTION: tabled until March to organize in spring
- c. Implementation of new recreation funding guidelines for 2023, and need for a paid coordinator (Called a Recreation Coordinator) (Sienna and Rosemary) Discussion of whether we do need a designated Recreation Coordinator. Or whether we can afford.
