My name is Christine Edwards and I live at

in Jordan River.

I'm writing in regards to the proposed resort at 11237 West Coast Rd.

I would just like to say that I think it is a wonderful idea and I support it 100%.

Sandcut beach has become very popular and often the parking lot is too small to accommodate the number of people that come to visit. They park along the road and create an unsafe bottleneck on the highway and I fear someone is going to get hurt.

This proposal would give a great alternative parking area as well as accommodation and other services in an area that has become a very desirable destination with the improvements to the Pacific Marine loop.

I ran a food truck in Jordan River this past summer and fall in partnership with the Pacheedaht First Nation, and I can assure you that there are plenty of tourists that will be grateful for an option of somewhere to stay in the area. There are many AirBnBs in Jordan River but most are booked solid May-October and the campgrounds are completely full the entire time. I had numerous international visitors approach my food truck asking for help to find somewhere to park their RVs or camp for the night and I had direct them hours away with no guarantees. There are also many people camping illegally in the woods or on logging roads for lack of any other options, and the proposal for the property at 11237 could help drastically reduce this problem.

I know many people are against development along the Wild West Coast and will fight to restrict it on principle alone, but I think it would be folly to deny what is a well thought out, eco friendly option for growth that could fill a void and also benefit the area.

# Re.: Sandcut/Rockbottom Creek Cabin & Campsite Proposal – Proposed Zoning Amendment RZ000280 (11237 West Coast Road); Proposed Bylaw No. 4518

I wish to offer my comments and concerns with the shortcomings of the development proposal for the Sandcut/Rockbottom Creek area noted above being considered at the APC meeting on February 7, 2023. I am a resident of Shirley familiar with the area and its attributes and have been involved in the preparation of the Shirley/Jordan River Official Community Plan (OCP).

I am of the opinion that the development proposal application should be referred back to the JDF Land Use Committee (LUC) with a recommendation for the LUC to refuse it as it does not meet the interests of the community as expressed in the OCP. Some on my concerns include:

- 1. The consistency of the proposal with the Shirley/Jordan Rive Official Community Plan (OCP) needs to be clearly determined. This is not clear from the staff report.
- 2. The proposed extensive development will have significant impacts on the rural character of a remote, rural area. It will result in increased activity in the forest interface, increased wildfire risk, increased interactions with large mammals and other wildlife and related safety concerns as well as affecting emergency planning and fire protection. Impacts on the area's rural character and measures of how to mitigate them are not provided.
- 3. The proposed 123 recreational/vacation uses and ancillary uses, including assembly uses yet to be identified, is not what was foreseen as low-impact tourism uses by the OCP review committee and community members who helped prepare the OCP.
- 4. Although the EA Report attached to tonight's agenda provides additional detail on mitigation and measures for environmental protection, these are currently short on detail for a site containing 123 uses affecting steep slopes, wildlife, climate related wildfire issues and sensitive ecosystem areas.
- 5. No information is provided on how water will be provided either for the proposed uses or for fire protection. No fire protection plan is provided. I believe one water licence for domestic use already exists on Rockbottom Creek. At the most recent LUC meeting the proponent stated there will be an application to the province for a water licence for the resort. No mention has been made to existing often very low summer flows for Sandcut and Rockbottom Creeks, the adjacent unnamed creeks as well as McManus Creek within the

same watershed. The critical water situation in this area is described in **Section 310 Water** of the OCP as follows:

Coastal areas around Point No Point, Sandcut Creek and Jordan River were identified in the mapping project as having highly vulnerable, unconfined aquifers due to the high water table and permeable sand and gravel soils....

Future climate change may result in a net increase in rainfall, with more severe heavy rain events leading to potential flooding and landslides. Increased drought in summer could see slower groundwater recharge resulting in insufficient in-stream flow to support fish habitat and domestic water supply.

Any water drawn from the aquifer or the adjacent creeks in the area will affect water levels and flows in the area and low summer flows in creeks will be further exacerbated. These creeks are habitat for otters, mink, raccoons, deer, bears and the occasional cougar and Roosevelt elk, as well as eagles, owls, ducks and shorebirds. The impact of further reduced flows on the watercourses and wildlife using them must be assessed and dealt with.

6. I have not seen any reference in the application to wildfire risk prevention, mitigation or related emergency measures such as evacuation and reducing fire spread. Similarly there is no reference to earthquake evacuation planning. There are no 'bear aware' and other wildlife awareness strategies for the proposal, all identified as considerations for development in **Section 464** of the OCP. That section also identifies needs for basic prevention of wildfires.

As a resident of Shirley, I am not convinced the best interests of the community are served by this development proposal. I would prefer that the application be turned down as it does not reflect the goals established by Shirley residents in the preparation of the Shirley/Jordan River OCP.

Re: Proposed Zoning Amendment RZ000280 (11237 West Coast Road)

The Shirley/Jordan River OCP Bylaw 4001 is referenced in the staff report as supportive of of low-impact tourism and low-impact recreational uses if land in Coastal Uplands Land Use designation is removed from PMFL, but also states that the OCP does not define low-impact. However there are some descriptions in the OCP of what is considered low-impact tourism:

Sec. 386 New Land Use Designations Pg. 76 "policies in the OCP supporting low-impact tourism activities such as guiding lodges and wilderness camps on lands designated Coastal Uplands"

Sec. 385 Local Economy Pg. 74 "development of opportunities related to outdoor recreation and tourism that are respectful of the environment and have a small physical imprint. Dispersal of recreational businesses throughout the community rather than being concentrated in one area is the preferred pattern for this type of land use. Large scale uses like recreational vehicle parks and destination resorts are not supported"

As a resident who sat on the OCP Citizens' Committee, I can tell you that the scale of what is proposed for these properties is not what was envisioned. The scale plus multiple cabins, a convenience store and more would not be considered by anyone who lives in a rural area as consistent with a wilderness camping location.

By a rough calculation at a minimum of 2 people per cabin and camping site, plus staff residing on site and a caretaker + family (?), and considering that in this climate those sites could be occupied year-round, this development could account for about half of what is projected in the OCP for the population increase of 457 by 2024 for all of Shirley and Jordan River.

I don't know how this bylaw amendment could be considered consistent with the OCP, as the staff report says there are no lands in the Bylaw 2040 area currently subject to the CR-2 Zoning. The uses allowed by that zoning, and certainly not the amendments to the CR-2 Zone now proposed would not have been considered in the OCP or in determining the OCP consistency with the RGS, since they did not exist for reference or comparison purposes at the time.

There is no mention in the staff report of environmental concerns such as wildfire risks with camping in a forested area, the identified highly vulnerable aquifer of the area, wildlife protection or corridors of habitat connectivity. And very importantly no mention of ground water protection or water source for a commercial development of this size, at

a time when residents of Shirley/Jordan River are experiencing the effects of climate change and drought on our already threatened precious domestic water sources. All of these are important components of the OCP.

The entire environmental report was not included in the information for the LUC to consider at their meeting January 17<sup>th</sup>. Now that it is, I see no mention of the areas of high intrinsic aquifer vulnerability on the property shown on Map 3, Water Resources Pg 30 of the OCP. These areas were identified by the Province and the Vancouver Island Water Resources Vulnerability Mapping Project.

The same Map 3 shows points of water wells and water diversions. There is one domestic water licence on Rockbottom Creek for one residence. Contrary to what the proponent stated at the LUC, it is unlikely they could obtain a commercial license to provide domestic water for so many sites. Having experience with applying for water licenses on other creeks for just one residence, I know that those applications are usually not successful and if they are successful only for a limited quantity and not during the dry months. I also know, from having been a Jordan River Regional Park Steward for 6 years, that McMannus Creek dries up entirely and Sandcut Creek can slow to just a trickle in the summer.

When questioned at LUC about wildfire protection, the proponent said he had a Wildfire Protection Plan which was not available for Land Use or seemingly not now for the APC. He also said they had plans to train the staff to fight forest fires! It is not at all realistic to think that young staff could have the skill and training to fight wildfires or even be permitted by the Province to do so.

The APC should remember the Marine Trails Resort application a number of years ago that was rejected because of it's scale, impact on the environment and proximity to the world class Juan De Fuca Marine Trail Provincial Park. The reasons for that rejection are still current, but now it is Jordan River Regional Park, or Sandcut Beach that is at risk. And also remember that Marine Trails Wildfire Protection Plan was to train the guests to fight the fires! Equally unrealistic.

I think this proposal should not proceed, it is not what was envisioned by the community or in the Shirley/Jordan River OCP. The APC should recommend to the LUC that the proposal is not supported.
