4. Delegations/Presentations

4.1 Randy Cunningham re: Southern Gulf Islands Tourism Partnership Society

- Independent non-profit society.
- Managed by an elected tourism sector Board of Directors.
- Includes Salt Spring Island and surrounding Southern Gulf Islands.
- To date, the society has received roughly 1 million in grant funding.
- Covid-19 pandemic caused operational delays.
- A discussion regarding regional funding opportunities occurred.

5. Director and Chair Reports

Director Holman briefly reported:

- Re-elected as Capital Regional District (CRD) Salt Spring Island Electoral Area Director for the 2023-2026 term.
- Local Community Commission (LCC) won voter approval with an election to take place at a date to be determined in 2023.
- Will be be working with the Ministry of Health in regards to the recent on island overdoses.
- The Commission requested clarity in regards to the future of the Community Economic Sustainability Commission (CESC) and Director Holman responded that the CESC would dissolve following the LCC election process.

6.1 Community Economic Forum Update

- Community engagement, pop-up boards, in person interviews, etc. to report on CESC updates.

6.2 Southern Gulf Islands Tourism Partnership (SGITP) Big Picture Update

 Recorded under item 4.1 Randy Cunningham re: Southern Gulf Islands Tourism Partnership Society.

6.3 Grow Local Big Picture Update

- Established in April 2022.
- Two contactors were hired to expand agriculture on Salt Spring Island.
- Local Salt app created to unite local farmers and food producers.
- School meal programs and restaurants purchasing from local farmers.
- Creating a new ordering system for bulk buyers and sellers.
- Commissioner Duynstee stated that the program requires a dedicated part time coordinator, especially if scaling up in the coming years.
- Last month of the project is November 2022 with a final report available by December 1, 2022.

6.4 2023 Salt Spring Island Community Economic Sustainability Operating Budget

• The Commission expressed support for the Salt Spring Island Economic Sustainability Coordinator position and further stated the importance in hiring the coordinator to write the overall CESC plan.

5.1 Brian Webster, Anne Macey, and Marion Hargrove re: Invasive Species Knotweed – 262 Rainbow Road

- Chemical control concern for food and public safety expressed.
- Volunteer agreements for ongoing mechanical control methods suggested by numerous delegates.
- The suggestion for mechanical control to minimize spread suggested.
- The suggestion for castor oil application to minimize spread suggested.

5.2 Portlock Park Master Plan

- Support for baseball fields and soccer fields expressed due to high demand.
- Track around the perimeter of the property to be considered.
- The Commission noted the importance in team sports.
- The Commission noted the limited playing fields available on island.
- Support for pickleball courts (separate from tennis courts) expressed.
 Further support for pickleball courts at Portlock Park expressed.
- The Commission noted children utilize the existing playground.
- Support for tennis courts on Portlock and/or Rainbow Road property expressed.
- Senior youth 12+ require larger playing fields.
- The Commission acknowledged that Portlock Park is utilized from open to close every day by several user groups as well as individuals seeking recreational amenities.

4.1 Seth Wright, Manager, Government Relations, & Tristan Ford, Transit Planner, BC Transit Update

- BC Ferries shore power updates at Fulford Harbour and potentially Vesuvius Bay discussed, with a suggestion made for BC Transit and BC Ferries to connect about future BC Transit electrification charging locations.
- Ridership has not fully recovered post pandemic.
- Poor road conditions on Salt Spring Island contribute to more frequent maintenance repairs.

- The Commission asked about the potential turn around option for Croftonbrook and BC Transit staff responded that turn around options are not ideal due to potential safety hazards.
- The suggestion for a smaller passenger vehicle for Croftonbrook was made.
 BC Transit staff confirmed that sprinter style vans had been explored however, the maintenance is considerably higher due to different design standards.
- Fuel and maintenance cost increases in the 2023/24 budget.
