FINANCE/INFORMATION REPORT

Feb 13, 2025

- 1. Treasurer report **Finals Dec 24** Final adjustments included CRD interest income, CRD labour charges, Hydro charges and minor other adjustments. The operating surplus of \$33, 374 from a total budget of \$96,281 and donations/ cost recoveries of approximately \$6,000 has been transferred to the capital account. This does not include the BC Hydro regreening grant of \$4600 which was not paid nor received until Jan 2025 although the expenses incurred for the project were reported in 2024. The capital account is now at \$161,680.
- 2. Motion to approve transfer of net overhead charges to the operating account from Japanese Memorial Garden.
 - "I move that the overhead charged by CRD to the Japanese Memorial Garden in the amount of \$367.33 (net of the interest income earned) be charged to the MIPRC operating account."
