6. OPERATIONS REPORTS

- 6.1 **Trail Inventory and Map:** Commissioner Tretick reported that the Chamber of Commerce Map is nearly complete, which will inform the update of the PIPRC map. Additional copies of the current map will be ordered as needed.
- 6.2 **PIPRC Asset Mapping:** Almost all sites have been visited and documented by Commissioners Suh, Baille and Cartwright. Next step is for Lori to review the information collected with Ben to identify any gaps.
- 6.3 **Maintenance**: Ben circulated a report prior to the meeting, and highlighted:
 - -Enchanted Forest–Ben will monitor wet areas over the summer as part of PIPRC's commitment to support the Covenant at the site.
 - -Gowland Point signage was damaged and will be replaced.
 - -McKinnon Road requires work. Lori will follow up with CRD regarding site licenses.
 - -Pump Track requires 20 yards of soil. Clover/native seed mix will be planted for cover. George will cost. Ben will organize volunteer support to spread soil.
 - -Boardwalk extension will be costed and mapped by Ben for the next meeting.
 - -Magic Lake Dock is pending.

- 6.4 **Restoration:** Erin O'Brien's report, on behalf of PICA, was circulated prior to the meeting. Erin highlighted the return of wildlife to restored areas. Erin requested reports from Commissioners conducting site visits regarding any invasive removal needs. Moving into broom removal at George Hill and mulching for summer at multiple sites. Beach clean ups are underway and April 26 is the main disposal date. Rob will host a PIPRC booth for Schooner Way Trail.
- 6.5 **Capital Projects**: Rob's report was circulated prior to the meeting.
 - -Schooner Way Trail bid process closes this month. An additional \$500K for Stage 2 from Medicine Beach to the School has been secured through a provincial grant. Plans for routing near the mini dip is underway and will involve engagement with the Islands Trust Conservancy.
 - -Thieves Bay Pavillion design options are being reviewed.
 - -Dog Park parking options are being reviewed with the Ministry of Transportation. Rob will recirculate the proposed site map to the Commission. Commissioner Frick noted another possible site option near Firehall #2 where there were historical water line concerns. Director Brent noted that he can liaise with the Water District if needed. Rob will visit that site to assess.

Commissioner Tretick will arrange notice to the community and signage. Commissioner Suh will develop a summary document on dog waste management options. Chair Leroux thanked Pender Island waste management for their continued support.
