# 5. Community Homelessness Report

Staff presented an overview of the 2024-2025 Community Homelessness Report (CHR).

- The CHR is an annual requirement under the Reaching Home program.
- This year's CHR reflects input and addresses considerations raised in previous years.
- Staff engaged with HICC in January 2025 to clarify the CHR requirements for the current reporting cycle, particularly given that the full report cannot be completed at this time due

- to the ongoing Federal-Provincial Alignment Project and the anticipated expansion of the Homeless Individuals and Families Information System (HIFIS).
- HICC revised the requirements for this year's CHR, outlining that all CEs in British Columbia are only required to complete Section 1 of the report.
- A key part of this year's report is the collaboration between the CRD and the Victoria
  Native Friendship Centre (VNFC), which serves as the Indigenous Homelessness
  Community Entity (ICE). VNFC has actively participated in the development of the report
  and has shared it with the Indigenous Community Advisory Board (ICAB) for review. The
  ICAB has expressed its support and will formally sign off on the report once it is approved
  by this board.
- CHR Findings The Victoria region continues to benefit from the \$120 million Regional Housing First Program, a partnership between the CRD, BC Housing, and the Canada Mortgage and Housing Corporation. The CRD is finalizing the Alignment Project and VNFC identified critical service gaps.

# 7. CE Administrative updates:

- The Point in Time (PiT) Count was conducted March 26, 2025. There were 192 Volunteers, and the Community Social Planning Council of Greater Victoria (CSPC) & HSABC are currently compiling data; CSPC will then develop a final report.
- The PiT Count is a Reaching Home requirement. The next PiT Count is scheduled the fall of 2026.

# Alignment Project:

- The purpose of the Alignment Project is to bring together the Federal Reaching Home Program and BC's Homelessness Strategy (Belonging in BC), resulting in better services for people at risk of or experiencing homelessness in BC.
- Currently in Phase 5 of a five-phase project Implementation at Provincial and Community Levels.
- CEs are currently reviewing 4 documents for sign-off:
