The meeting was called to order at 2pm

#### 1. Territorial Acknowledgement

Chair Walsh provided a Territorial Acknowledgement.

#### 2. Welcome and Introduction

A round table of introductions took place for the benefit of the new members.

#### 3. Approval of Agenda

#### 4. Approval of Minutes – June 6, 2024

#### 5. Review of 2025 Proposed Events and Restrictions on Elk Lake

The 2025 Proposed Events and Restrictions Schedule on Elk Lake was discussed and agreed upon with Committee members.

#### 6. Brookleigh Boat Launch Parking Signage

Chair Walsh commented that staff are working with the sign shop to improve signage at the Brookleigh boat launch. He mentioned that staff have conducted patrols and provided education to park users. Members suggested to paint bright colors for different parking areas at the location. Parking is an ongoing issue, and it is a challenge to obtain compliance.

## 7. Buoys

Since the departure of Tracey Moss, previous Chair, this item is on hold and there is no current update available.

## 8. Lake Levels

Chair Walsh mentioned that the weir is open and that lake levels are within the prescribed rule curve targets. It is a balance between recreational and fisheries values.

## 9. Event Parking at Eagle Beach

A Parfitt mentioned that there has been a struggle with event parking during rowing regattas. Some participants and spectators have received warning notices as they park along the roadway where the signage indicates no parking. To ensure that participants and spectators are parking in designated parking stalls and to avoid being ticketed, the Rowing Club must provide their own parking ambassadors for the event.

## 10. Water Quality

A. Parfit pointed out that parts of the lake are good and there is an observed difference in water quality in the middle of the lake due to the new oxygenation system but will the lake as a whole improve due to the system. Chair Walsh stated that blue/green algae is becoming more frequent and happening longer. He mentioned that the system deals with oxygen at the deeper levels of the lake, and it does not account for run off.

## 11. New Business:

### a) Membership Appointments

J Mollin mentioned the membership for the Committee as follows:

- Brad Bracjich, representative for Saanich Police, is retiring at the end of December 2024. He introduced the new representative, Karen Robinson. The appointment of the new Saanich Police representative will go to the CRD Board Committee in 2025.
- Melanie Parrott, representative for the swimming community, appointment expires on December 31, 2024. Melanie is up for reappointment and is to forward her interest to J Mollin before the end of 2024.
