CRD Regional Trails Visitor Use Survey - 2019

The Board received the 2019 CRD Regional Trails Visitor Use Survey which summarizes key responses provided by respondents regarding their use of, and experiences on, the regional trails. The survey results will help guide staff in planning for the future management of the regional trails and identify emerging visitor use trends, as well as provide a baseline for subsequent surveys.

Regional Trails Widening Study

The Board received the Regional Trails Widening Study and directed staff to conduct public engagement on the 6.5m separated use pathway design with lighting and implementation priorities as recommended, including consideration of low-intensity lighting on the trail segment adjacent to Swan Lake, aiming for balance between wildlife and public safety considerations. Staff will report back to a future committee meeting with further recommendations and will aim to expedite public engagement and detailed design, with a view toward having a shovel ready project.

Wastewater Treatment Project Q3 and Q4 2020 Quarterly Reports

The Wastewater Treatment Project Q3 and Q4 2020 Quarterly Reports were received by the Board for information from the Core Area Liquid Waste Management Committee. Award of Contract – Construction Management Services for the Demolition of Oak Bay Lodge

The Capital Regional Hospital District Board awarded a contract to Unitech Construction Management to oversee the demolition of the Oak Bay Lodge building. Investing in Canada Infrastructure Program; COVID-19 Resilience Infrastructure Stream (Regional Parks Service)

The Board endorsed the submission of a grant application for the Galloping Goose Bridge Replacements & Repair Project through the Investing in Canada Infrastructure Program, which provides funding to public infrastructure projects in BC. This new stream of grant funding was developed in an effort to provide immediate funding to eligible recipients, including local governments, to help address the impacts of COVID-19, and fund other infrastructure projects.

Investing in Canada Infrastructure Program; COVID-19 Resilience Infrastructure Stream (Electoral Area Projects)

The Board endorsed the submission of three grant applications for Electoral Area projects through the Investing in Canada Infrastructure Program, which provides funding to public infrastructure projects in BC. The three grant applications include the Willis Point Water Tank Project in the Juan de Fuca; the Drake Road Trail Upgrades Project on Salt Spring Island; and the Einar's Hill By-Pass Route (Multi-Use Trail) Project on the Southern Gulf Islands.
