Galiano Island Parks and Recreation Commission offers annual funding opportunities to groups and organizations that provide recreational benefits to the residents of Galiano. The Commission currently defines a recreation program as a formally organized community activity for the purpose of amusement or pleasure and is considered “fun”. This chosen activity is done in one's leisure or discretionary time. GIPRC considers the following criteria when evaluating applications:

**PARTICIPATION:**

- reaches a significant portion of the community
- broad in appeal and accessible to the community
- targets underserved community demographics (teens, elders)
- includes an outreach plan to Indigenous and First Nations community members
- inclusivity

**IMPACT:**

- number of participants and program hours
- primarily focused on recreation
- potential to reduce isolation and increase well-being

**DESIGN:**

- has a plan to ensure islanders are made aware of the activity
- activity is achievable within the time frame
- activity fills a gap or does not duplicate other activities

**BUDGET:**

- offers good value
- complete and clear on how the grant will be used to enhance recreation on Galiano
- provides sufficient details: expenses, sources of other funding and/or description of in-kind

**Please note that applications will only be considering if:**

- ✓ Reports have been submitted for any previous GIPRC funding.
- ✓ A satisfactory and complete application form is received by April 15, 2026.

Funds can be used to purchase program costs including moveable recreation equipment, operating supplies, room rentals or wages. Eligible groups and projects include, but are not limited to recreation, athletic and cultural clubs, community hall groups, and community events. In the past, GIPRC has provided support to pre-school programs, to activities for school-age children; to the fitness centre for persons of all ages; to sports activities; to continuing education programs workshops and events; to children's summer programs and to community events and recreation activities.
