

# 2025 Water Rates

## Highland & Fernwood Water Service Area

Capital Regional District | Effective January 1, 2025

### Explanation of annual costs per resident:

- The Capital Regional District bills Salt Spring Island residents on a quarterly cycle.
- The total annual Fixed Use Charge is divided up into quarterly payments per single family dwelling unit or equivalent.
- The Water Consumption Charge is based on your metered use each quarter and billed accordingly.
- The Parcel Tax is an annual fee and will appear separately on your property tax bills.

- Watch for notice of meeting date for the Highland/Fernwood Water Service Annual General Meeting to be held in the spring of 2025.
- 2025 Water Rates, which are subject to change, are based on the CRD's preliminary Financial Plan. The Financial Plan with possible revisions will receive final approval by the CRD Board in March of 2025.
- Payment is due within 30 days of issuing the water bill. A late payment charge of 1.5% will be added after the billing due date.
