4. CHAIR'S REMARKS

The Chair welcomed everyone back after the summer and stated that he hoped everyone was well rested and ready to continue the good work that this Commission does.

5. PRESENTATIONS/DELEGATIONS

6. GENERAL MANAGER'S REPORT

6.1. Water Supply Outlook [Verbal]

T. Robbins stated that it's been a hot dry summer with record temperatures and that even into September daily demand continues to be in the 170 to 180 mega liters per day range and the September average is 150 mega liters per day. Demand should begin to slow over the next couple of weeks as cooler temperatures move in.

Staff responded to questions from the Commission regarding:

- Budget impacts due to increased sales from the higher than normal water usage this summer.
- Available water flows to support hatchery and fish streams. Water has continued to be released throughout the summer.
- Request from the Commission to post the water release volumes in the weekly water watch reports.
- Aquifer water levels versus Sooke Lake Reservoir water levels and whether there
 this any relationship, there is no information to confirm that Sooke Lake Reservoir
 is connected to the aquifers.

7. COMMISSION BUSINESS

7.1. Rocky Point Water Upgrades Tender – Recommendation to Award

I. Jesney provided a summary of the report as circulated in the agenda package.

Staff responded to questions from the Commission regarding:

- Price variance between the two bidders which could be reflective of higher costs of materials and supplies.
- Any budget surplus at the end of a project is put back into the capital reserve fund for the service.

MOVED by Commissioner Kahakauwila, **SECONDED** by Commissioner Rogers, That the Juan de Fuca Water Distribution Commission approves the award of Contract 2019-537, Rocky Point Water Upgrades, to Industra Construction Corp. in the amount of \$7,927,793.44 plus GST.

Staff was asked to provide an update on the once-through-cooling motion that was passed at the last Regional Water Supply Commission meeting. Staff advised that the recommendation included \$20,000 funding for a rebate program. Staff will be preparing a report that will outline how the rebate program would be implemented, what the rebate would be set at as well as the most recent information on how many once-through-cooling units are in service in the region.
