<u>SUBJECT</u> Juan de Fuca System Expansion - Skirt Mountain - Tender Award Recommendation

ISSUE SUMMARY

To seek the Juan de Fuca Water Distribution Commission's (Commission) approval to award a contract for the Juan de Fuca System Expansion – Skirt Mountain project (Tank 4, McCallum Pump Station and Pump Station 7).

BACKGROUND

The Skirt Mountain project is part of the Juan De Fuca (JDF) Water Distribution System capital plan (Project 23-01). The location of the project is shown in Appendix A and the scope of the project includes:

- Tank 4 Bolted steel tank with a volume of 2,750 cubic metres
- McCallum Pump Station
- Pump Station 7
- Supply main to existing Skirt Reservoir completed on budget by Capital Regional District (CRD) staff in 2021

The project budget was amended by the Commission on December 7, 2021 and now totals \$9.11 million for design and construction and is entirely funded by the JDF Development Cost Charge (DCC) program. A breakdown of budget components is as follows:

Three tenders for Tank 4, McCallum Pump Station and Pump Station 7 were received on February 3, 2022 as follows:

- 1. Coast Utility \$6,673,803.00 + GST
- 2. Industra \$7,288,728.82 + GST
- 3. CanWest Mechanical \$8,175,388.90 + GST

The project consultant, Stantec, reviewed all three tenders and deemed the low tenderer, Coast Utility, to be qualified to deliver the project. The tendered amount is within the allocated construction budget of \$8,109,000.

As the delegated signing authority limit for the Chief Administrative Officer is \$5 million, the Commission's approval to award the contract is required.

Alternative 1

That the Juan de Fuca Water Distribution Commission approves the award of Contract 2021-723, Juan de Fuca System Expansion – Skirt Mountain, to Coast Utility in the amount of \$6,673,803 plus GST.

Alternative 2

That the Juan de Fuca Water Distribution Commission not approve the award of Contract 2021-723, Juan de Fuca System Expansion – Skirt Mountain, to Coast Utility and direct staff to cancel or retender the project.

CONCLUSION

The Tender is ready to be awarded to Coast Utility in the amount of \$6,673,803 plus GST. The Tender has been reviewed and it complies with the tender requirements and Coast Utility is deemed qualified to undertake the project. There is sufficient funding available through the JDF Development Cost Charge program and the tendered amount is within the allocated budget. The delegated signing authority limit for the Chief Administrative Officer is \$5 million, therefore approval of the award of contract by the Juan de Fuca Water Distribution Commission is required.



SUBJECT Goldstream Avenue Water Main Project Update

ISSUE SUMMARY

To provide the Juan de Fuca Water Distribution Commission (Commission) with an update on the Goldstream Avenue Water Main Project.

BACKGROUND

This project is to replace aging asbestos cement (AC) water main along Goldstream Avenue from Leigh Road to Veterans Memorial Parkway (appendix A for map). The main is also being upsized to account for hydraulic capacity due to the future relocation of the Regional Water System's Transmission Main #4. The project includes the following components:

- The replacement of 1,600 metres of 200 millimetre (mm) diameter AC water main with 400 mm diameter ductile iron (DI) water main,
- The replacement of a total 200 metres of 200 mm and 150 mm diameter AC water main along side streets between Leigh Road and Veterans Memorial Parkway with 300 mm diameter DI water main.

On December 7, 2021, the Commission recommended to the Capital Regional District Board, that the 2022 Juan de Fuca Water Distribution Service Capital Budget and Five Year Capital Budget be amended to increase the Goldstream Avenue Water Main Project from \$5 million dollars to \$5.8 million dollars to account for anticipated construction cost escalation.

The Goldstream Avenue Water Main Project tender closed on January 20, 2022 with the Capital Regional District (CRD) receiving three qualified bids. All bids received were over budget with the lowest bid, at approximately \$7 million, being approximately \$1.2 million dollars over budget.

CRD staff, with advice from the project's engineering consultant Parsons, will not be awarding a contract due to the tender prices, which exceed available budget and do not represent good value in the CRD's opinion. The tender will be cancelled. Cost drivers contributing to the high cost include: hours of work constraints; contractor labour shortages; material cost increases and permanent and temporary paving requirements.

Although the Goldstream Avenue Water Main has been identified as a high priority project under the AC Replacement Program, the CRD is planning on rescheduling the work for 2023 and will be investigating alternative options for construction. Some of these options may include utilizing night work and/or CRD forces and material suppliers to complete the project. The use of CRD forces may save costs related to labour, insurance and profit.

Staff will be following up with a report regarding a capital plan budget amendment to reflect the revised schedule.

CONCLUSION

The Goldstream Avenue Water Main Project was tendered and the bids received are significantly over budget. CRD staff, with advice from the project's engineering consultant Parsons, will not be awarding a contract due to the tender prices, which exceed available budget and do not represent good value in the CRD's opinion. Although the Goldstream Avenue Water Main has been identified as a high priority project under the AC Replacement Program, the CRD is planning on rescheduling the work for 2023 and will be investigating alternative options for construction.








SOOKE LAKE RESERVOIR STORAGE SUMMARY 2021 / 2022

FAQs

How are water restriction stages determined?

Several factors are considered when determining water use restriction stages, including,

- 1. Time of year and typical seasonal water demand trends;
- 2. Precipitation and temperature conditions and forecasts;
- 3. Storage levels and storage volumes of water reservoirs (Sooke Lake Reservoir and the Goldstream Reservoirs) and draw down rates;
- 4. Stream flows and inflows into Sooke Lake Reservoir;
- 5. Water usage, recent consumption and trends; and customer compliance with restriction;
- 6. Water supply system performance.

The Regional Water Supply Commission will consider the above factors in making a determination to implement stage 2 or 3 restrictions, under the Water Conservation Bylaw.

At any time of the year and regardless of the water use restriction storage, customers are encouraged to limit discretionary water use in order to maximize the amount of water in the Regional Water Supply System Reservoirs available for nondiscretionary potable water use.

Stage 1 is normally initiated every year from May 1 to September 30 to manage outdoor use during the summer months. During this time, lawn watering is permitted twice a week at different times for even and odd numbered addresses.

Stage 2 Is initiated when it is determined that there is an acute water supply shortage. During this time, lawn water is permitted once a week at different times for even and odd numbered addresses.

Stage 3 Is initiated when it is determined that there is a severe water supply shortage. During this time, lawn watering is not permitted. Other outdoor water use activities are restricted as well.
