#### **Mail-in Ballots**

In circumstances where the number of nominees in the applicable service area equals more than the number of positons available, mail-in ballot packages will be mailed to owners and occupants in the service in October. Detailed instructions on how to vote by mail will be included with the ballots at that time.

In the event of a tie, or where an insufficient number of ballots are received, the Electoral Area Director will appoint members to vacant positions.
